

**Memphis Grizzlies Ultimate Gameday Experience
Presented By Clubtails**

OFFICIAL RULES. The following rules (the “Official Rules”) apply to the below-referenced Promotion.

PROMOTION PERIOD. The “Clubtails Ultimate Gameday Experience” (the “Promotion”) begins January 24, 2026, and ends March 14, 2026 (the “Promotion Period”). **Multiple entry periods exist within the Promotion Period.** The entry periods will be on January 24, 2026, February 7, 2026, February 8, 2026, and March 14, 2026, with each entry period beginning at 11:00 AM local time and ending at 2:00 PM local time on the applicable day (each, an “Entry Period” and, collectively, the “Entry Periods”). The Promotion is offered only in the states of Tennessee, Mississippi, and Arkansas, subject to the eligibility requirements set forth below.

NO PURCHASE NECESSARY. A purchase will not improve your chances of winning. Void where prohibited by law. This promotion is not a gambling activity under Tennessee law as it offers a free method of entry and winners are selected randomly, not based on any payment or consideration.

ELIGIBILITY. The Promotion is open only to legal residents of Tennessee, or legal residents of Arkansas or Mississippi living within one-hundred fifty (150) miles of FedExForum, who are at least twenty-one years of age at the time of entry. Promotion is void outside this area and where prohibited by applicable law. Employees and agents of Memphis Basketball, LLC or their affiliated companies and agencies, Geloso Beverage Group (“Sponsor”), the National Basketball Association (“NBA”) and its Member Teams, NBA Properties Inc., and each of their respective immediate families (parents, children, siblings, spouse) and household members are not eligible to participate in the promotion. Entrants must have the Official Memphis Grizzlies Mobile App downloaded and must be signed up to receive Mobile Tickets at the time of entry in order to be eligible.

TO ENTER. During each Entry Period, eligible individuals (the “Entrants”) may enter the Promotion for an opportunity to win a prize (the “Prize”). Entrants may enter the Promotion by completing the entry form available on https://memphism basketball.formstack.com/forms/clubtails_retail_driver. Entries generated by script, macro or other automated means or by any means which subvert the entry process are void. All entries become the property of Memphis Basketball, LLC and will not be acknowledged or returned. Entry is limited to one (1) entry per person per Promotion Period.

WINNER SELECTION. **Multiple entry deadlines and drawing dates apply.**

One (1) Entrant will be randomly selected as the winner (each, a “Winner”) following the conclusion of the second Entry Period and one (1) Entrant will be randomly selected as a Winner following the conclusion of the fourth Entry Period (i.e., there will be two (2) total Winners – one winner from the pool of Entrants from the January 24 and February 7 Entry Periods and one winner from the pool of entrants from the February 8 and March 14 Entry Periods, and each Winner will receive the Prize associated with that set of Entry Periods, as further described below (e.g., the Winner who entered during either the January 24 Entry Period or the February 7 Entry Period will receive the Jan/Feb Prize and the Winner who entered during either the February 8 Entry Period or the March 14 Entry Period will receive the Feb/Mar Prize). Non-winning entries eligible for one Prize drawing will NOT remain eligible for subsequent drawings throughout the Promotion Period. A total of two (2) Winners will be selected from among all eligible entries received.

PRIZES. There will be one (1) of each Prize awarded, which will be awarded to the winner of the drawing for the corresponding Entry Periods (e.g., the Winner who entered during either the January 24 Entry Period or the February 7 Entry Period will receive the Jan/Feb Prize).

JAN/FEB PRIZE. – JANUARY 24 ENTRY PERIOD AND FEBRUARY 7 ENTRY PERIOD. The Winner will receive two (2) Grizzlies tickets to February 23, 2026, versus the Sacramento Kings. (\$250 value)

FEB/MAR PRIZE. – FEBRUARY 8 ENTRY PERIOD AND MARCH 14 ENTRY PERIOD. The Winner will receive two (2) Grizzlies tickets to March 30, 2026, versus the Phoenix Suns. (\$250 value)

Prizes are awarded “as is” with no warranty or guarantee, either express or implied. Winners will be responsible for all federal, state and local taxes and fees and other costs and expenses associated with Prize receipt and/or use that are not expressly included in the Prize description, including but not limited to transportation to and from the game and Winner’s home, meals and beverages. with cash or another prize of comparable or greater value. All Prize details are at Memphis Basketball, LLC's sole discretion. Limit one (1) Prize per person. Every Winner, at the request of Memphis Basketball, LLC will be required to sign and return an affidavit of eligibility, liability release, and/or publicity release (except where prohibited by applicable law) in form and substance determined by Memphis Basketball, LLC in its sole discretion. Every Winner will also be required to produce a proof of age and residence to Memphis Basketball, LLC, and will further be required to complete and return all required documents within forty-eight (48) hours of the day of being notified that such person is a Winner. Failure to return all documents in the time and manner specified may result in disqualification. Any Winner who does not comply with these Official Rules may be disqualified. Return of any Prize or Prize notification as "undeliverable" will result in disqualification and selection of an alternate Winner. By entering, each Entrant agrees to hold harmless and indemnify Memphis Basketball, LLC, Sponsor, the City of Memphis, Tennessee, the County of Shelby, Tennessee, the NBA and its Member Teams, NBA Properties, Inc. and each of their respective direct and indirect parents, subsidiaries, affiliates, members, directors, officers, governors, employees and agents ("Released Parties") against any and all liability, damages or causes of action (however named or described), with respect to or arising out of either (i) such Entrant's participation, or (ii) the receipt or use of the prizes awarded in the Promotion.

RELEASE. Each Entrant hereby releases, waives and discharges the Released Parties from any and all claims of damages or causes of action, including but not limited to, death, personal injury or loss or damage to property, which such Entrant or any of the Entrant's representatives, heirs, next of kin or assignees may have or which may hereinafter accrue to the Entrant or Entrant's representatives as a result of the Entrant's participation in the Promotion or the receipt or use of the Prizes awarded therein and which may be asserted by the Entrant, or Entrant's representatives.

Released Parties are not responsible for lost, late, incomplete, inaccurate, stolen, delayed, misdirected, undelivered or garbled entries, or emails or other communications of any kind or postage-due, damaged or illegible mail; or for lost, interrupted or unavailable network, server, Internet Service Provider (ISP), website, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Promotion, including, without limitations, errors or difficulties which may occur in connection with the administration of the Promotion, the processing entries, the announcement of the Prize(s), or in any Promotion-related materials. Released Parties are not responsible for injury or damage to participants' or to any other person's computer or other device related to or resulting from participating in this Promotion or downloading materials from or use of the websites used in connection with the Promotion.
