

OFFICIAL RULES. The following rules (the “Official Rules”) apply to the below-referenced Promotion.

NO PURCHASE NECESSARY. The Slim + Husky’s Pizza “Make Your Mark Fan Art Promotion” (the “Promotion”) begins March 3, 2023 and ends March 17, 2023, (the "Promotion Period"). The Promotion is offered only in the states of Tennessee, Mississippi, and Arkansas and is open only to legal residents of Tennessee, Arkansas or Mississippi (within one-hundred fifty (150) miles of FedExForum).

CONTEST & PRIZES: Individuals (the “Entrants”) may enter the Promotion for an opportunity produce art for one (1) poster giveaway, two (2) tickets to the April 4, 2023 home game and \$1,000 cash (the “Prize”). Entrants may enter the Promotion by completing the entry form available on <https://grizzlies.com/fanart> (“Entry Form”). The Entry Form sets forth the contest themes and art requirements. One (1) Entrant will be selected as the winner (the “Winner”) and will receive one (1) Prize.

PRIZE VALUE: The total Prize will not exceed the value of \$1,600. No Prize transfer. No Prize substitution or cash equivalent except at the sole discretion of Memphis Basketball, LLC, due to Prize unavailability for any reason and only then for a Prize of equal value. For the avoidance of doubt, should any game be canceled, Memphis Basketball, LLC will not provide a Prize substitution. Void where prohibited.

WINNER REQUIREMENTS: Every Winner, at the request of Memphis Basketball, LLC will be required to sign and return an affidavit of eligibility and liability release. Every Winner will also be required to produce a proof of age and residence to Memphis Basketball, LLC, and will further be required to complete and return all required documents within forty-eight (48) hours of the day of being notified that he/she is a Winner.
